

The Quantix Inflation Index 2Q22 Target Weights Announced

March 14, 2021

Launched in February 2022, with historical data available back to 2001, the Quantix Inflation Index ("QII") is a new benchmark for hedging inflation using the commodities market. The index references exchange-traded contracts linked to 24 physical commodities, and the second quarter 2022 target weights will be implemented during the standard April 2022 index roll.

There are no commodity additions or deletions in QII for this quarter. The sector weights and individual commodity weights are in line with the 1Q22 Target Weights, with no sector or individual commodity increasing or decreasing more than 2%. The Petroleum sector retains the highest weight, at 39.77%, even after a small decrease from 1Q22.

The target weights for all QII components for 2Q22 are listed below:
